WHO CAN APPLY:

Auctioneers must fulfil following eligibility criteria:

- (a) Provide details of the firm/company in Annexure-I
- (b) Must not be blacklisted by any Department of the Government of India or of any State/or by any PSU/Autonomous Organisation of Government. An undertaking regarding non-blacklisted of the auctioneer by any Government Organization must be furnished by the auctioneer with the tender document in the format given at Annexure II.
- (c) Must be registered as a Recycler/Reprocessor/Dismantler of e-Waste with Central Pollution Control Board, Ministry of Environment and Forests, Government of India or with the State Pollution Control Board or State Governments dealing with E-waste etc. Annexure-III
- (a) Should be registered with GST with Departments of Government of India/State Governments.

The Terms & Conditions of the auction are as under:-

- a) The auction is on "AS IS WHERE IS BASIS."
- b) Each auctioneer has to deposit an Earnest Money in the form of demand draft/pay order for <u>Rs.8,000/- (Rupees Eight thousand only)</u> in favour of "Finance Officer, JNU, New Delhi" on or before 23rd December, 2024 (5.00 PM). EMD of unsuccessful auctioneer shall be returned immediately after completion of auction process. EMD shall not be accepted under any circumstances after the end date of submission of documents.
- c) No auctioneer shall be allowed to participate in the auctioning process without depositing the EMD. Cheque/Cash shall not be accepted as EMD amount.
- d) The Micro and Small enterprises (MSEs) and the firms registered with National Small Industries Corporation (NSIC) etc. are exempted from submitting the EMD as per prevailing rules. However, they have to submit the valid documentary evidence in support of MSE/Registration with NSIC (indicating the items for which they are registered.) alongwith the other requisite documents
- e) The successful auctioneer shall have to pay full amount of the auction value through NEFT/RTGS within two days from the date of receipt of letter regarding award of contract, failing which the contract may be cancelled and the EMD shall be forfeited. - g) The auctioneer shall submit an undertaking that e-waste items will be stored/processed/disposed off as per Rule 12 of Chapter IV of *e-Waste (Management and Handling) Rules, 2011* (Annexure III).
- h) The successful auctioneer shall have to submit a copy of certificate after disposal of the e-waste that the disposal of e-waste has been done as per Rule-12, Chapter IV.
- The highest auctioneer will be allowed to take out the dismantled materials from the campus within 3 (Three) days from the date of acceptance of letter of award and after making payment of full auction value on issue of the gate pass by the School of Life Sciences.
- j) If the auctioneer does not remove the auctioned dismantle materials from the site within 3 days after depositing the full auction value, Assistant Registrar, SLS may confiscate the balance materials lying at the site and the auctioneer shall have to pay Rs.2,000/- per day as penalty. No material shall be allowed to take out unless the penalty is paid by the auctioneer.
- k) The security of the dismantled materials would be the entire responsibility of the highest auctioneer after the auction and it will be his/her responsibility to any damage by way of pilferage, fire or any other unforeseen clarity and no claim on this account shall be entertained.
- No damage shall be caused to the existing property of this Office or any other Offices in the premises while removing the materials from the site. Any loss/ damage to the property of this Office or any other Offices in the premises or injury or personal accident suffered by any person due to negligence or action of the successful auctioneer or his authorized worker/supervisor will be borne by successful auctioneer and they will be indemnified.
- m) The auctioneer should also enclose the certified copy of the valid registration certificate issued by the Central Pollution Control Board or the State Pollution Control Committee failing which he/she will not be allowed to participate in the auction.
