Vidhu Verma is currently a Professor, Centre for Political Studies, School of Social Sciences, Jawaharlal Nehru University, New Delhi, India. She has been educated at the universities of Delhi, JNU, and Oxford. She has also been Chairperson of the Centre for Political Studies (CPS), the Gender Sensitization Committee against Sexual Harassment (GSCASH), and the Centre for the Study of Discrimination and Exclusion (CSDE), in JNU. She was also Director of the Educational Records Research Unit (ERRU), School of Social Sciences, JNU.

She teaches courses in Political Philosophy and Political Theory. Her areas of research include Comparative Political Theory, feminist political theory, State, religion and democracy, affirmative action policies, and social justice in India. She has recently edited 'State in India: Ideas, Norms and Politics' (Orient Black Swan, New Delhi 2018), 'Unequal Worlds' (OUP, New Delhi 2015), and Secularism, Religion and Democracy (OUP, New Delhi 2019). She has co-edited and contributed to volumes on State, Law and Adivasi: Shifting Terrains of Exclusion (Sage, New Delhi 2022) and 'Empire of Disgust' (OUP, New Delhi 2018). She is the author of three books including "Non-discrimination and Equality in India: Contesting boundaries of Social Justice" (Routledge, London 2012), and articles in several journals.

She has forged outstanding international collaborations in research and publications with scholars from the USA, UK, Japan, Southeast Asia, France, and Germany. She was a visiting fellow, at Maison Des Science de L'Homme, Paris, under UGC sponsored Indo-French cultural exchange program in 1994 and under the ICSSR-sponsored Indo-French cultural exchange program in 2006. She was a General Fellow (2000-2002), and Senior Fellow at, the Indian Council of Social Science Research, New Delhi (2008-2010). She was a senior fellow with ICAS at the University of Erfurt, Germany (1st October- 10th December 2019).

She has been involved with many projects as Director, Political Institutions (Collaborative), UPOE, JNU, (2005-2007), and as Principal Investigator, of the sponsored project on 'Changing Conceptions of Legal Justice in India', ICSSR, (2014-2016). She is also a core member of the ICAS TM4 module based in Germany.
