1. A Master's Degree with at least 55% marks (or an equivalent grade on a point-scale, wherever the grading system is followed).
2. An eminent scholar having a Ph.D. degree in the concerned/relevant disciplines with Specialization in any one specific area of: Molecular Endocrinology / Human Genetics / Anatomy, Physiology and Pathology of the human body.
3. A total research score of 120 as per the criteria given in Appendix II, Table 2, of UGC Regulations, 2018.
4. A minimum of ten (10) years of post-Ph.D. teaching experience in university/college as Assistant Professor/Associate Professor/Professor, and/or research experience at equivalent level at the University/National Level Institutions.
5. Evidence of having successfully & independently guided Two (2) doctoral candidates.
6. Actively engaged in research with evidence of published work of high quality: A minimum of 10 original research publications (NOT review article) in the peer-reviewed or UGC-listed journals with at least four papers having impact factor 4 or more (Thomson Reuters/Clarivate Analytics) as first/corresponding author in any one specified area of specialization/expertise mentioned in criteria 2.
7. Having experience of implementing at least two Major research projects as principal investigator (PI).
8. At least 10 years of the service should be left.
