CIRCULAR

With reference to order No. F. No. SDM/VV/COVID-19/2020/444 dated 27.07.2020 from Government of National Capital Territory of Delhi, office of the SDM (Vasant Vihar), New Delhi District 6th Floor, Palika Bhawan, R. K. Puram, New Delhi; all stakeholders of the University are hereby informed that the COVID-19 positive cases are detected from all parts of the University.

In view of increasing number of Covid-19 in the University, a visit has been made by Rapid Response team on 24th July, 2020. The areas affected were Saraswatipuram, Poorvanchal, Paschimabad and Dakshinapuram. Maximum clustering of cases were seen in Block No. 2 (821 to 828), Block No. 5 (735 to 740) Block No. 6 (709 to 714) Block No. 07 (729 to 734) in Saraswati Puram and it has been decided to restrict the area and no movement should be allowed. Also for the rest of the residents, non essential movements have been restricted.

The above precautionary measures will remain continued in force upto 11.08.2020 in order to break the chain and to minimize/stop the spread of Corona Virus (COVID 19).

Those persons and their family members who are under home quarantine and or houses have active case may be facilitated with essential services/food items etc. if any assistance required please contact at telephone numbers- 011-26704029, 8130573744.

In view of above, all residents of the campus are requested to comply with the following precautionary measures in letter and spirit.

1. Maintain proper social distancing and use of face mask and other protective gears.
2. Avoid non essential movements in the Campus and stay safely at home.
3. Avoid inviting friends and relatives in the Campus.
4. Avoid mass gathering in the Campus.
5. Individuals above 60 years and below 10 years should remain inside of their houses.
6. The residents of Campus may cooperate with Security officials.

7. Social distancing may be followed by all persons while in market and maintain minimum 06 feet distance with each other.
8. If someone is experiencing any symptom, cold, flu-like or have returned from another location, may self-isolate himself/herself for 07 days; under intimation to the University Health Centre, Security Department and Administration at Telephone No. **011-26741636**, or Security Control Room at No. **011-26704029** or Administration at No. **011-26704008 (09 A.M. to 05 P.M.)**, **011-26704752 (24x7)**, In case of emergent situation, individual concerned may telephonically contact to the designated CMO of the CGHS dispensary inside the Campus for any further guidance or Ministry of Health and Family Welfare's 24X7 helpline at **011-23978046**.
