Objectives of The Course:

Demographic changes, human settlement patterns, land-use decisions, and political and social policy dynamics have increased vulnerability to natural and man-made disasters. Planning and policy processes and interventions can help reduce disaster vulnerabilities and increase resilience at every stage of the disaster management cycle: disaster mitigation, preparation, response, and recovery. In recent years, the redistribution of risk has created conditions for natural and technological disasters to become more widespread, more difficult to manage, and more discriminatory in their effects. Policy and planning decision-makers frequently focus on the impact that human settlement patterns, land use decisions, and risky technologies can have on vulnerable populations. However, to ensure safety and promote equity, they also must be familiar with the Institutions of Disaster Management Structures that are present at each stage of the disaster management cycle. Therefore, this course will provide students with the broader understanding of international, national and regional and local institutions and agencies that are associated with disaster risk reduction and disaster management. It also will provide an understanding foundation for assessing and managing the social and political processes associated with disaster policy and planning
