#### Introduction:

The course would give comprehensive understanding of the new perspectives on nationalism and enable the students to undertake research in this area. The idea of nationalism constitutes an important area of study in Comparative Political Analysis. In recent past much academic debates and socio- cultural developments took place in the post-Cold – War world, where the liberalism occupied a centre stage in economy, polity and ideologies in context of Liberalisation, Globalisation and Privatisation. There are also socio- cultural forces that are active in revival of socio- cultural identities that is adding a new perspective to nationalism. The course aims to give a comprehensive understanding of the classic texts on nationalism and also to the more important recent work. The course will examine a wide range of nationalism from Indian as well as western perspectives. Various theories, ideologies, approaches and emerging challenges related to nationalism would enrich the students with a research bent in this area. This course proposes to introduce students to the phenomena of nations and nationalism. It takes a global perspective from the long nineteenth century to the twenty-first to attempt to understand why nations and nationalism have remained such attractive analytical objects for researchers, as well as why they have rendered so differently in theory and practice across time and space.
