**Objective**: Since the 1980s, the Republic of Türkiye has strived to be recognised as a multi-regional power in the Black Sea, Balkan, Caspian, South Caucuses, Mediterranean and West Asian region, and in turn as a middle power in a globalised world. However, due to inherent economic limitations, the Turkish foreign policy ambitions remain challenged. This course seeks to provide an overview of Türkiye's domestic politics and foreign policy with an emphasis on developments in the 21<sup>st</sup> century.

**Learning Outcome**: The course will enable students to develop an understanding of Türkiye's domestic politics and foreign policy and the interlinkages between them.

### **Course Outline**

**Unit I. Evolution of Modern Türkiye:** Rise and Fall of Ottoman Empire; Turkish Nationalism; Emergence of the Republic; Ataturk and Modern Turkey; Kemalism.

**Unit II. Contours of Domestic Politics:** Nature of the state; Political system; Civil-Military Relations; Religion and State; Emergence of Multi-party system; AKP.

**Unit III. Trajectories of Foreign Policy:** Discourses and determinants; Cold War and post-Cold War; Alliances and friendships; Regional policy.

**Unit IV. Türkiye in the 21**st **Century:** Identity debates; Emergence of Erdoğan; Strategic depth and zero-problem with neighbours; Blue Homeland; Neo-Ottomanism.
