COURSE NO: SM 640 WORKERS' HEALTH IN INDIA

Scant attention is paid in India to the subject of work and its impact on health. This Course on Work & Health is meant to be an initial step in the direction of creating more awareness and knowledge base among public health students on nature and organization of work in contemporary societies, and its impact on health, and to engage with questions of how to direct such knowledge to better work and working conditions so that they do not harm health.

The Course will introduce students to the idea of Work as a Social Determinant of Health, as a key social dimension affecting population health and well-being. We will look at the nature and organization of work in contemporary society, and the impact of modern working practices and working conditions on workers, specifically their health and safety implications, and engage with questions such as which sections of working people are most affected, why so and how.

The objectives of the course are:

- A. To discuss and understand work as a social determinant of health, associations between work-related factors and health, specifically
- significance of employment/working condition for health of workers and their families, hence for health of populations.
- impact of workplace environment on health of workers.
- B. To guide students to search for, compile, assess and critically interpret relevant scientific and epidemiologic, theoretical, methodological, and empirical knowledge on workers' health issues in India.
