Conditions:-

1. The quotation for the work shall have validity for a period 30 days from the date of opening of quotations. 2. The work shall be carried out as per specifications defined in the NIQ.
3. All taxes shall be deducted as per Govt. of India rules applicable.
4. Time allowed for completion of above work is **10 days**.
5. Earnest Money amounting to **Rs.1,992/-** should be deposited in the shape of Pay Order/Banker's Cheque/Demand Draft in favour Finance Officer, JNU. No quotation will be entertained without Earnest Money.
6. Security deposit @7.5% of quoted amount shall be recovered from the bills paid to the agency and the same shall be refunded after warranty period of six months.
7. **The Quotation shall be placed in sealed envelope marked "Quotation" which shall be submitted with the name of work and due date of opening written on envelope.**
8. The firm has to produce self attested copies of all relevant documents such as PAN no., GST Registration, Electrical contractor License etc. along with the quotation.
9. The quoted rates shall be inclusive of all taxes, cartage etc and nothing shall be paid extra over / above quoted rates.
10. Payment shall be made after satisfactory completion of work.
