Course Objectives

- To introduce students to the initial as well as emerging perspectives in the sociology of knowledge and highlights its significance for the study of form and content of knowledge.
- To offer a glimpse of the many approaches in sociology of science and technology.
- To introduce students to different axes of knowledge, power and hegemony and to steer towards pluralistic basis for sociological conceptualisation.
- To explore the future of alternative and embedded knowledges.
- To encourage critical awareness among social science students about their own discipline.

Assessment

- 1. 50% Semester end examination (2 credits)
- 2. 50% Intra semester assessment (2 credits):

Text based presentation with write up of 2000 words. (Submit 7 days after presentation) Field based Term paper of about 4000 words

Soft copies of the readings will be made available in the Google Classroom. Lectures, presentations, discussion and guest lectures will be part of classroom teaching.

Students can choose one article or chapter from the list of optional readings for the **text-based tutorial presentation** and submit an independent write up on the same. You may also choose material of your choice pertaining to the syllabus after discussion with course teacher. A handout containing the key points of your presentation *must* be given to the class by the presenters at the time of presentation. The write up would be evaluated for: analytical and conceptual rigour, references and your own critical insights on the material.

Term paper would be on a topic decided by you in consultation with the teacher and should be field based. The criterion of evaluation of term paper would be: Originality in the choice of topic and methods of data collection, perspective and argument, observation and creative insight into information collected and the references. The Term paper also needs to be presented in the class

The end semester examination will be essay based.
