The course seeks to impart a theoretically grounded and methodologically nuanced understanding of the Systems of family and Kinship in the global Village today. It begins with the argument that family, marriage and kinship are not naturally given but culturally constructed. The key principles, basic concepts as well as classical theories to the study of Family and kinship will be discussed and critiqued, based on ethnographies of various communities in the world. Problems of theorization due to structural functional and regional variations in family, kinship and marriage "system," or the lack of it will be closely examined. The institution of family and household will be critically examined in terms of its structures, processes and gender relations. The emerging dimensions of family life, conjugality and kinship networks in contemporary India will be a challenging learning task of this course, given the diverse academic training of the students.
